ORGANIZATION MISSION IS TO ESTABLISH ANIMAL WELFARE THROUGH SPAY/NEUTER, VETERINARY CARE AND TREATMENTS FOR RESCUERS AND IMPROVERISHED OWNERS ANIMALS, FUNDING TRAINING FOR VETERINARIANS TO LEARN BETTER SURGICAL SKILLS, PROVIDE FOOD AND HELP FOR SHELTER ANIMALS, AND COORDINATE WELFARE AND ADOPTION OF ANIMALS INTO GOOD HOMES.
